

THE CORPORATION OF THE TOWNSHIP OF ASPHODEL-NORWOOD

BY-LAW NO. 2009-72



Being a by-law establishing the remuneration and expenses for members of Council and members of any local board.

WHEREAS Section 283 (1) of the Ontario Municipal Act 2001, S.O. 2001, c. 25, provides that a municipality may pay any part of the remuneration and expenses of the members of any local board of the municipality and of the officers and employees of the local board; and

WHEREAS Section 283(4) of the Ontario Municipal Act 2001, S.O. 2001, c. 25, states that no part of the remuneration of a member of Council or local board paid under this section is deemed to be for expenses incidental to his or her duties as a member and municipality or local board shall not provide that any part of the remuneration is for such deemed expenses; and

WHEREAS Section 283(5) of the Ontario Municipal Act 2001, S.O. 2001, c. 25, states that despite subsection (4), if a resolution of a municipality under subsection 255(2) or (3) of the old Act is not revoked before January 1, 2003, the resolution shall be deemed to be a by-law of the municipality and one-third of the remuneration paid to the elected members of the council and its local boards is deemed as expenses incidental to the discharge of their duties as members of the council or local board; and

WHEREAS Section 283 (7) of the Ontario Municipal Act 2001, S.O. 2001, c. 25, provides that, on or after December 1, 2003, a council shall review a by-law under subsection (5) at a public meeting at least once during the three-year period corresponding to the term of office of its members after a regular election.

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ASPHODEL-NORWOOD ENACTS AS FOLLOWS:

1. The members of the Council of the Corporation of the Township of Asphodel-Norwood shall receive annual remuneration as follows,

Effective January 1, 2010:

Reeve	\$8,231.14
Deputy Reeve	\$6,482.03
Councillors	\$5,967.58

2. The members of Council of the Corporation of the Township of Asphodel-Norwood who are required to be out of the Township for the purposes of attending conferences or on Township business or acting in the capacity as members of a local board or other body shall be compensated:
 - a. for expenses in accordance with the provisions of the Human Resources Policy approved by Council;
 - b. but if members of Council attending an approved convention they shall receive one hundred, ninety dollars and fifty-five cents (\$190.55) per day plus registration, mileage, parking, accommodation at the posted convention rate, and a sixty dollars (\$60.00) meal allowance

per day upon submission of registration and appropriate receipts, for a maximum of three (3) days in attendance at the convention.

3. Persons appointed by Council to a local board, other than members of Council, shall receive compensation for expenses actually incurred while acting in such capacity for accommodation, meals, registration, and mileage in accordance with the provisions of the Human Resources Policy.
4. One-third of the remuneration paid to the elected members of Council and its local boards is deemed as expenses incident to the discharge of their duties as members of the council or local board.
5. This By-law shall take effect as of the first day of January 1, 2010.
6. By-law No. 2009-01 and all by-laws contrary to this by-law are hereby repealed.

By-law read a first, second and third time and finally passed this 21st day of December, 2009.
